

## CCC Intelligent Solutions Announces Pricing of Upsized Secondary Offering of 22 Million Shares of Common Stock

CHICAGO--(BUSINESS WIRE)--Jan. 4, 2024-- CCC Intelligent Solutions Holdings Inc. (the "Company") (NASDAQ: CCCS) today announced the pricing of the previously announced secondary offering of shares of the Company's common stock (the "Offering") by affiliates of Advent International, L.P. (the "Selling Stockholders"). The Offering consists of 22 million shares of the Company's common stock, upsized from the previously announced 20 million shares. The shares will be offered from time to time for sale through negotiated transactions or otherwise at market prices prevailing at the time of sale. The Offering is expected to close on or about January 8, 2024, subject to the satisfaction of customary closing conditions. The Offering consists entirely of shares of the Company's common stock to be sold by the Selling Stockholders, and the Company will not receive any proceeds from the sale of the shares being offered by the Selling Stockholders.

J.P. Morgan, Barclays and Citigroup are acting as joint book running managers for the Offering. The Offering is being made pursuant to an effective shelf registration statement on Form S-3 (Registration No. 333-267793), which has been filed with the Securities and Exchange Commission ("SEC") and became effective on October 14, 2022. The Offering is being made only by means of a prospectus supplement and the accompanying base prospectus.
